

### **DIRECTIONS TO STONY BROOK UNIVERSITY AND THE CHARLES B. WANG CENTER**

Take the Long Island Expressway (LIE, I-495) to Exit 62, and follow Nicolls Road (Route 97) north for 9 miles. The main entrance to the University is on the left (do <u>not</u> take the south entrance, which occurs about <sup>3</sup>/<sub>4</sub> of a mile before the main entrance). Turn left into the campus. Proceed to the parking garage to the left of the Administration Building. The Charles B. Wang Center is located directly across from the parking garage. It is the large gray building with red entryway fencing, and is also noted for the modern representation of a Pagoda on the rooftop. The telephone number at the Wang Center is 631-632-6320.

### **DIRECTIONS TO THE MARTHA CLARA VINEYARD FROM THE LIE**

The vineyard is located at 6025 Sound Avenue, between Northville and Mattituck. To reach it from the Long Island Expressway traveling east, the recommended (and simplest) route is to take Exit <u>71</u>. Make a left and go north on Edwards Avenue for approximately 3 miles, to the second traffic light. Make a right here onto Sound Avenue and drive east for about 10 miles.
